

“HARM REDUCTION,” America’s Disastrous Drug Policy.

Who Created It, How It Began, Grew, And Led to America’s Descent Into the Abyss As a Narco-Nation.

ABSTRACT

“HARM REDUCTION” DEFINED

Today, an estimated 1,000 people die every day on American soil owing to drug related causes, almost all directly or indirectly related to marijuana. The true intent of “Harm Reduction” is to legalize possession and use of all drugs, and not hold criminals accountable for crimes. There is no intent to raise awareness of the harms of marijuana or other drugs. The result is America is no longer safe, for anyone. Two individuals are primarily responsible for orchestrating the problem: ETHAN NADELMANN who created “Harm Reduction” with the goal of legalizing all drugs; and GEORGE SOROS who used his vast resources to control the Democratic Party and make it national drug policy, with no regard for the millions of lives that it has destroyed. Both should be held accountable as domestic terrorists. Allowing this to happen for 16 years also represents a complete betrayal by the federal government of their inherent responsibility to protect the people. Millions of lives have been lost, or destroyed. The increase in the size of the marijuana market, and influx of fentanyl, and abdication by the federal government to enforce CSU laws have grave implications for the future of America. Immediate action must be taken to remedy the problem.

ETHAN NADELMANN

ETHAN NADELMANN holds three degrees from Harvard, including a JD and PHD, and another from the London School of Economics. He taught Public Policy at Princeton for 7 years, from 1987 to 1994. He is a powerful speaker, Unfortunately, if “Harm Reduction” was his version of good drug policy, all the formal education didn’t endow him with good judgement or analytic skills, or a sense of morality.



Nadelmann created the concept based on the premise that the War on Drugs was doing more harm than drugs themselves, especially to Blacks and Hispanics in inner cities. Blacks consisted of about 13% of the population yet committed 37% (+/-) of the crimes. He ignored social factors, such as 70% of blacks were raised in homes without a father in low-income neighborhoods where drugs flourished. Gangs replaced the lack of effective parenting, as is the case now.

“Harm Reduction” ignores Prevention entirely, THE single most important element of sound drug policy. It promotes drug possession and use as a human right. It assumes addicts want treatment, when the need for drugs is so compelling most do not. And it doesn’t punish crimes committed by addicts and drug users because they have a health problem, not a criminal problem. According to the ADAMII report published by the Office Justice, 83% of crime is committed by people who test positive for drugs, 59% for marijuana alone. Never mind the impacts on society. The intent was to legalize drugs.

In 1989, to affirm his true intent was legalization, Nadelmann stated: *“The government is no longer tied to the public, and as soon as we get the press on board, the public will be so disillusioned **we will get full legalization.**”* Soros was happy to oblige by buying the media, which he continues to control to this day.

Nadelmann introduced “Harm Reduction” in Western Australia in 1993/1994 which was to serve as a model to be replicated in the U.S. The results were catastrophic in terms of lives mental illness, addiction, crime, and families destroyed. If reducing harm was ever really the motive, that should have been the end of it. But it wasn’t. Even 15 years later Nadelmann, with financial support from Soros, was still campaigning in Australia for legalization.

In 1996, Nadelman spearheaded California Prop 215, *The Compassionate Use Act*, which legalized “medical marijuana.” Soros and two other billionaires funded the initiative and 56% of voters approved it, and the journey for State legalization of marijuana began. Clinton could have and should have stopped it, but then Soros, Bill, and Hillary operated as a team (Soros’ words). Obviously, money trumped honor. As a show of Soros influence, when Clinton first took office he reduced the office of national drug control from 146 to 25 people. When the drug problem got far worse, General Barry McCaffrey was appointed as Drug Czar. It is interesting to note that during the Senate confirmation hearings, Senator Joe Biden said *“... the average addict is committing 180 crimes a year. Don’t even study the problem, just fix it.”* In his final years as President, Biden released 2,500 prisoners for non-violent crimes. Obviously, money helped reshape his philosophies. Then he had the audacity to reward Soros, America’s biggest enemy from within, with a Media of Freedom, an outrageous insult to the nation! He deserves to have a rope around his neck, not a medal..

SOROS AND NADELMANN CREATED THE DRUG POLICY ALLIANCE (DPA)

In 1998 Soros and Nadelmann joined forces and created the Drug Policy Alliance (DPA) to advocate for “Harm Reduction.” Nadelmann also wrote a letter to Kofi Annan, Secretary General of the UN, urging an open dialogue regarding the future of global drug policies, *“...one in which fear, prejudice and punitive prohibitions yield to common sense, science, public health and human rights.”* The letter was signed by George Soros, Oscar Arias, Walter Cronkite, Alan Cranston and others. Despite the fact that “Harm Reduction” and legalization has caused nothing but misery and death on two continents, “Harm Reduction” is still promoted by the UN promoting compassion for addicts with no regard for public safety or the victims. True compassion requires preventing addiction to begin with.



There was a pause from 2001 to 2009 when George W. Bush was in office and John Walters was Drug Czar. Then came Obama, who Soros sponsored for office, and “Harm Reduction” became national drug policy. AG Eric Holder was happy to oblige. The government issued the Cole memo, abdicating the federal government’s responsibility to enforce federal laws for controlled substances, while State legalization of marijuana for medicinal and recreational marijuana took off in earnest with Soros at the helm. When the financial crisis hit in 2008, Soros proclaimed, *“this is the*

highlight of my career.” In all probability, he helped craft the sub-prime housing scheme during the Clinton years which led to the crash. . In the next 8 years, **he increased his net worth by \$20 billion.**

Soros’ actions are reminiscent of the Opium Wars in China, where the British used military force to keep the markets open for opium for almost 100 years. The motive was twofold. One, for the money which flowed back to the Crown. And 2, it weakened the State so they couldn’t fight back. In or about 1912 Sun Yat Sen came into power and finally stopped it after 40 million men had died of overdose, and 200 million were still addicted. Soros’ motives seem the same, except he doesn’t need military force in our frail system of government where politicians and policies are decided by money.

President Trump could have and should have stopped it in his first term, but didn’t. Instead, he gave Soros and marijuana a free pass, maybe because he didn’t understand the dangers of marijuana\ Or because of his past business dealings with Soros, or the fact his son-in-law Jared Kushner was a business partner with Soros. National drug policy was still “Harm Reduction” where it remained throughout the Biden Administration. There is now reason to be concerned given Trump’s stated comments in support of legalization of marijuana in Florida that he will ignore the facts and continue to push legalization. Or rescheduling marijuana from Schedule I to III. despite the quantifiable human and economic harms and cost to the America people. At last count, there were 445,000 people in the marijuana trade, marketing brain damage, mental illness, addiction, suicides, mass murders, psychosis, traffic deaths, and DNA damage causing chromosomal abnormalities in a fetus, and their progeny. After 16 years of suppressing the truth about the harms of marijuana, the perception of harm is very low, while the harms are very high.

Roughly 1,000 people are dying every day of drug-related causes. The vast majority started with marijuana. Every day we have **300 overdose victims, 1.8 mass murders, roughly 70 homicides, 135 suicides, and 106 traffic deaths** for a total of 611 without counting all those who die from related medical issues like strokes, heart attacks, cancer, et al. **No war in American history compares.**

Legalization didn’t get rid of the black market. Instead, it grew exponentially, with cartels invading the US from all over the globe. Their environmental impacts are devastating, and the products they sell throughout the US are laden with toxins. **The estimated economic cost of substance abuse is \$3.73 trillion,** according to Recovery Centers of America 2019, **over four times the Defense Budget.**

Soros has also been financing anything and everything that undermines American values. Aside from “Harm Reduction” that includes Defund the Police, Antifa, WOKE to influence education starting in elementary schools, Open Borders and the invasion of illegal immigrants, state legalization of marijuana, funding DA’s that won’t prosecute crime, foreign cartels that are illegally growing and selling marijuana and other drugs, and legalization of marijuana and other drugs at the state level. And he controls mainstream media and the Democratic Party.

It could happen again with the right leadership and less influence from Soros and others who want to deconstruct and destroy America's exceptionalism.

The harms of marijuana, particularly for anyone under age 25 whose brains are not fully developed, are very significant. Cannabis is also known to cause DNA damage, passed from parents to child, that cause physical and mental abnormalities not only in the child but in their future line of children and grandchildren. Says Dr. Paula Gordon, an expert who has an online educational program on cannabis, "...If the public and public health officials studied the research, they would surely not put in place policies that

encourage the use of THC that has unpredictable and harmful effects, the use of which contributes to further use, addiction and a-motivational syndrome, violent behavior, and even suicide."

Clearly, aside from fueling the demand for opioids and other drugs, marijuana itself is a threat to the future of our young people. For that matter, to humanity itself. Yet at last count, there were 445,000 people in America growing or selling this poison, with impunity.

These pictures are worth a thousand words. While America was being decimated by Covid-19, Pelosi was holding up the stimulus bill by inserting clauses that helped the illicit marijuana business. Pelosi and
